## 5. Minutes of the Board of Studies:

The heads of all the departments presented the minutes of the Board of Studies for approval. Sanskrit minutes was read by Dr. Neeraja

instead of Ms. Dhanalakshmi and the minutes of Physics department was presented by Mr. G. Saraswathi instead of Ms. D. Vidyavathi due to ill health. The Academic Council approved the minutes of the departments with the following suggestions.

- a. English: Prof. Madhusudhana Rao suggested arranging group discussions and essay writing practice in the language classrooms.
  - b. Telugu: Prof. Krupachari advised to change the pattern of question paper as to allot 10 marks for paragraph, 5 marks for translation i.e. from English to Telugu.
  - c. Home Science: Prof. Dattatreya Rao suggested changing the name from Home Science to Nutrition. Mr. Subramanyam an Industrialist suggested the title as Home scientist and to start business like Hotel to increase the income.
  - d. Statistics: Prof. Dattatreya Rao suggested to give full form instead of giving abbreviations in the syllabus as it leads to confusion.
  - e. Computer Science: Prof. Dattatreya Rao suggested to implement C++ in V Semester and also practicals to be in the course including basic of electronics.
  - f. Commerce: Prof. Dattatreya Rao suggested, instead of fundamental C++, Database Management Concepts can be included for the benefit of the Commerce students.

    - suggested to conduct Mock interviews in the classrooms.
    - suggested that counselling is necessary for girls for every 15 days either by a

Psychologist or by an Elder person.






