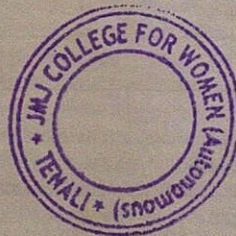

They will be placed on probation for a period of two years of duty within a continuous period of three years w.e.f. 05.05.2018 FN. They are assigned with Genl. No. noted against each in Guntur Rural District.

If their mother tongue and medium of instructions is not Telugu, they shall qualify themselves by passing the language test in Telugu conducted by the APPSC, Hyderabad within three years from the date of appointment failing which, they will be discharged from service.

It is further informed that, Women Police Constables (Civil) shall serve the Police Department for a minimum period of 5 years after completion of basic training failing which Women Police Constables (Civil) shall be liable to repay the pay and allowances or any other remuneration received by him in addition to the amount spent by the Govt on their training together with interest, as per the agreement bond executed by them. Recovery shall also be effected in case if discharged from the probation for misconduct or any other reason.





Women Police Constables (Civil) are liable to serve in all the specialized units viz. Intelligence, CID, Railways, Training Institutions etc., if he is posted to such unit.

Women Police Constables (Civil) shall occupy Govt quarter and stay in Police lanes where ever quarter are available and allotted to them.
